## **NOTIFICATION**

### **Publication Grievance Board**

As per the decision taken in the University Research Advisory Board meeting held on 14-07-2020 and Publication Incentive Board meeting held on 01-10-2020, Publication Grievance Board (PGB) is constituted with the following responsibilities:

1. Board shall function under the monitoring of Director, Department of R & I, Deans of Faculty of Medicine and Faculty of Allied Health and Basic Sciences, Registrar of The Academy.
2. Shall take independent decision without any bias or prejudice.
3. Submit recommendations with proposed action for the grievances.
4. Shall meet as and when grievances related to publications are forwarded to the committee.
5. Decision, recommendation and action to be submitted within 2 working days of our Academy.
6. Constitution of the board shall include 7 members.
7. The present board shall hold the office for a maximum of 2 years from the date of notification and may continue for one more term but not exceeding more than 4 years consequently.
8. Rotation of the members shall happen, retaining a minimum of 30% (2 members) of the existing members.
9. In case the existing member is relieved/ superannuated then he/she has to intimate the Chairman of the board 3 months well in advance and the Chairman of the PGB and on discussion with the Director, Department of R & I shall be replaced with a competent person.





12. In case Chairman is unable to conduct a meeting, then they can authorize a senior person of the PGB to chair the session and shall function as the temporary Chairman of that day.
13. All grievances decision shall be made only after updating to Hon'ble Vice- Chancellor of our Academy. However, before finalizing with the Hon'ble Vice- Chancellor of our Academy the Chairman of the committee shall call for a meeting and discuss with Director R & I, respective Deans and Registrar of our Academy.
